Dear Editor The League of Women Voters of Diablo Valley recommends a "Yes" vote on Orinda's Measure E, which will authorize the City to sell, over time, up to \$58,600,000 in general obligation bonds to finance improvements to roads, storm drains and water supply

infrastructure. Two-thirds of Orinda's roads are in very poor condition. One half of Orinda's storm drains are in danger of failing. Twenty eight percent of Orinda's fire hydrants produce insufficient water to put out a fire in a 1,000 square foot structure. The League supports measures that ensure revenues are both sufficient and flexible enough to meet changing needs for local government services. The City has instituted multiple safeguards by establishing a 7 member Citizens' Infrastructure Commission. The League strongly supports the involvement of non-elected citizens that provide oversight and implementation of the infrastructure improvements. In addition, there will be annual independent audits of the bond expenditures and the bond proceeds will be deposited in a special bonds proceeds account. "The City Council has encouraged all citizens to be engaged and knowledgeable about this important bond measure". The League strongly agrees with that sentiment. Please vote yes on Measure E on June 5.

As you know, 1978's Prop 13 stripped the tax base out of California coffers which had an enormously negative impact on the monies returned to local communities for critical initiatives like education. The upside of Prop 13 is that lifelong and newer residents to the state can still afford the taxes we pay on our homes to live here. But without those state tax dollars, each community has to pay for everything locally-especially things we really value like education. Pay as you go or pay for performance became the new standard when Prop 13 passed 29 years ago.

Fortunately in Orinda, the community has made a significant and sustained commitment to "excellence in our schools" and supported that vision financially through E.F.O. and by passing measures that enable that excellence.

While clearly not as emotionally engaging as education, the same parallel exists for California infrastructure and roads....communities have to "pay locally for results." The money will not come from the state, there is no "special budget" to draw from and the City of Orinda's annual budget of \$10M only allows for \$900K per year for roads unless we want to forgo police and fire protection and a city management staff. For those of you who attended the City meetings in January, you know there is no other viable nor rationale solution to improving Orinda's 92 miles of roads, drains and water flow to fire hydrants. In the post Prop 13 era in California, the only way to make these substantive improvements is to pay for it locallythere is no other solution.

So if you want to get this done, you have to vote YES on Measure E on June 5th.

I am homeowner, business owner and parent of two elementary school age children living in the Burton Valley neighborhood of Lafayette. I am writing to you regarding the dire straits of the roadways in Lafayette and urging all Lafayette residents to vote "Yes" to Measure C and Advisory Measure D on June 5, 2007 which will provide \$24M to fix our roads. Nearly thirty percent of our roads in Lafayette are failed! The failed roads not only lower our homes' property values, but are extremely dangerous to our children who walk and bike on these roads. It costs ten times more to fix a failed road than maintain a good road. Therefore, Lafayette tax dollars currently earmarked for fixing our roads are being used to maintain roads in good condition.
