Another project liked by the council is the construction of a living landscape berm in

the Theatre District to provide visual and sound separation from Highway 24. Staff noted that several long-term projects had been eliminated as financially infeasible, includ-

ing an aerial gondola, tunneling behind the existing support structures for the highway, or widening the overpass supports, all of which would definitely require a

corridor study. While Mayor Inga Miller agreed, she also pointed out that the city really needs to be looking at a complete fix, down the road, far out in the future. How-

ever, they need to be looking at how to maintain pedestrian safety and enhance bicycle safety in the meantime.
